## Rules and Submission Information

### Contest Rules

- Entries will include any bird species found within the EcoQuest Kayaking Adventure property boundaries, with prizes awarded for the best photographs.
- Entries must have been photographed between June 5-June 10th 2010. All entries will be submitted, documenting the location, time and date of the photograph.
- Entry Fee: \$10.00 per entry, limit 3 entries per person.
- Payment online via the EcoQuest Kayak Adventure website: [www.EcoQuestAdventure.com](http://www.EcoQuestAdventure.com)
- Deadline: Sunset, June 10th, 2010.
- All photographers are welcome: Amateur, Students, or Professional. You do not need to be a EcoQuest Kayak Adventure registered paddler to enter the Birds Eye Photo Contest.
- Judging will be conducted by a Judges' panel of local professional photographers. The Judges panel will narrow the entries to the top twenty photographs, which will be publicly displayed Saturday, June 12, 2010, during the Family Fun Festival. Prizes will be awarded to the top three entries as selected by the Judges' panel. An additional award will be selected by popular vote of attendees at the Family Fun Festival.
- All entries must include the following general information: photographer's name, mailing address, email address, and telephone number, as well as the Photograph Title, contest location, time and date taken.
- **SIZE REQUIREMENTS:** Please submit as original electronic files. Minimum size is 3300 x 2550 (8.5x11) at an effective resolution of 300 pixels per inch (PPI), color RGB and in JPEG format.
- All entries will become the property of North Florida Land Trust (NFLT) and may be used by NFLT for any purpose NFLT deems valid.
- Contest entrant must be the creator of the image and owner of the copyright for every image submitted.
- By submitting an entry in the contest, Entrants agree to grant NFLT permission and all rights to use the photo entry indefinitely for marketing purposes, which include but is not limited to including display of Entrant's photographic submission online or in printed material to promote NFLT and the NFLT Land Conservation programs.
- Entrants agree to authorize NFLT to announce and publish their name, address, and photograph in any forthcoming publicity without further remuneration, other than the prizes awarded in this contest.

### Submission of Entries:

- Only Digital Entries will be accepted. Any digital correction must be limited to correction of dust or scratches.
- A photograph submitted to the contest by entrant is testament that the entrant is the creator of the image and owner of the copyright for every image submitted.
- All entrants must have sufficient permission from any recognizable persons appearing in the photograph and be able to provide documentation if requested. Subjects of entries should be the natural environment in the EcoQuest Kayaking locations showcased this year.
